Introduction

In 1922 a young woman living in the Dalldorf Asylum gave herself the name of “Miss Unknown”. Miss Unknown would not stay anonymous for long. Court Case Outcomes and DNA Findings

Anna Anderson would file a petition for the Revocation of the Certificate of Inheritance in 1938. Anderson wanted to be seen in the eyes of the law as the missing Grand Duchess Anastasia. This would become the longest running case in German legal history lasting more than thirty years. The trial was separated into two parts, in each part Anderson would end up losing. In the end the court decided there was not enough evidence to deem her as Anastasia but also not enough evidence to deem her not. Finally, in 2009, DNA used from the bones of the Romanov remains would prove that the real Anastasia had died with the rest of her family in Siberia in 1918. Proving Anderson to be a fraud and at this point Anderson had already passed away.
